## Guidelines: Activ850 Summer Sports Programme

To help celebrate Glasgow's 850th anniversary, the Activ850 Summer Sports Programme will support sport and physical activity programmes for young people during the 2025 summer holidays.

This fund will provide funding to local voluntary sports clubs and community organisations to help young people get active, have fun and mark this historic milestone through sport and activity.



By bringing communities together and encouraging participation, we aim to create a lasting legacy of health, inclusion and celebration across the city.

# Eligibility

Glasgow based voluntary sports clubs and organisations that have demonstrated a commitment to promoting sports activities for children and young people.

Programme must include a minimum of 5 days of activity throughout the summer.

One-off trips or events will not be considered for support.

## **Use of Funds**

The fund must be used for equipment, venue hire, coaching fees as well as help to reduce participant fees or provide free spaces at activities from **Monday 30<sup>th</sup> June to Tuesday 12<sup>th</sup> August 2025**.

## **Application Deadline**

All application forms must be submitted by Friday 16<sup>th</sup> May 2025 to be considered.

## **Assessment Criteria**

Applications will be evaluated based on programme **impact**, **feasibility** and **inclusivity**.



## **Reporting Requirements**

Funded organisations must provide a brief report on how the funds were used and the impact of the programme.

Be willing to take part in social media or filming activities to demonstrate the impact of the programme.

#### **Frequently Asked Questions:**

#### Who can apply for the Summer Sports Programme fund?

Voluntary sports clubs and community groups with a structured sports programme for young people.

## How much funding is available?

One grant of £850 is available for each of the 23 Glasgow City Council wards.

#### How will I know if our application is approved?

Successful applicants will be notified via email by Friday 30th May 2025

#### What can I use the funding for?

We want to provide flexible funding that helps get young people in your community active during the summer. You know your community, so the funding could help with facilities, coaches or equipment as well as providing healthy refreshments to participants.

We cannot support projects that will take place outside of the Glasgow City Council boundary.

#### What supporting information do we need to provide?

This is public funding so you will be asked to provide your organisations governing document and proof of suitable bank account.

By applying for this funding, the expectation is that your organisation has appropriate Safeguarding and Vulnerable Groups policy and procedures and insurance cover in place.

#### Can I use the Glasgow 850 branding?
